March 7, 2020

Meeting Point: Super 1 Foods 3916 NE Evangeline Thruway. Carencro, LA 70520 @ 7:30am and leaving by 8am

- Leaving Carencro, turn right onto I-49 N.
- Take exit 23 for US-167/LA-744. Ville Platte exit.
- Turn left for Ville Platte.
- After driving through Ville Platte, turn right to stay on US-167 N.
 - We will drive through Bayou Chicot and Turkey Creek.
- When getting into Turkey Creek, turn right onto US-13/US-167.
 - Will not be able to go straight at this intersection.
- Turn left onto Cemetery Rd. This will be close to the intersection with US-13/US-167
- This can be easily missed. You have to turn left onto Cemetery immediately after the intersection.
- This road will change names to Glenmora/Turkey Creek Hwy.
- Turn left to follow Glenmora/Turkey Creek Hwy.
 - o If you go straight at this intersection, the road will change to Onyx Rd. Wrong way.
- Turn right onto US-165 N after crossing RR Tracks.
- We will be stopping at Forest Hill Elementary School for a break and to pick up more cruisers. 2032 10th St.

There is also a small gas station about 2 blocks from here. I guesstimate it will take us close to 2 hours to get here from our starting point.


- Continue North on US-165 N.
- Turn Left onto LA-112 W.
- We will drive through Melder, Elmer, Lisso, and Hineston.
- Turn right onto LA-121 N.
- In the town of Sulzer, Turn left onto LA-465
- Turn left onto LA-28 W
- Getting into Leesville, at the traffic circle, Take the 2nd exit onto US-171 S.
- We will drive through Leesville, New Llano, Rosepine, and Deridder.
- We will be stopping at Steamboat Bill's for lunch.

- When leaving Deridder, Continue straight onto LA-27 S/South Pine St.
- We will drive through DeQuincy and Sulphur.
- Drive under I-10 then turn left to merge onto I-10 E.
- Use the right two lanes to take exit 25 for I-210 E towards Lake Charles Loop.
- Continue on I-210 E.
- Take exit 4 for LA-1138-2/Nelson Rd.
- Keep left at the fork and follow signs to Casino Area.
- End in Parking Lot of Golden Nugget.

230 miles total. 4 hour drive time.


